**NOTIFICATION**

In exercise of the powers conferred by Clause (b) of Sub-section (1) of Section-3 of the Minimum wages Act, 1948 (Act 11 of 1948) read with Sub-Section (2) of Section 5 of the said Act and after considering the advice of the Committee appointed under Clause (a) of Sub-Section (1) of Section-5 of the said Act, the Governor of Tripura is pleased to revise the basic rates of minimum wages of the employees/workers engaged in the employment of **'Shops and Establishments'** in Tripura. The rates of wages specified in column -4 of the schedule below shall be payable to the different categories of workers/employees engaged in the aforesaid employment in the State of Tripura as specified in the corresponding entries in column No.3 of the schedule.

The revised minimum rates of wages shall come into force **with effect from 26/07/2017**


